## **Development Fund Draw Terms & Conditions**

- 1. Multiple numbers of entries by each individual are permitted, Open to adults aged 18 or over.
- 2. Entries are permitted by individuals, couples, groups, companies and other organisations. One individual's contact name and details must be supplied relating to each entry and where an entry is made by or on behalf of multiple entrants or an unincorporated group of entrants he / she will hold the ticket on their behalf. FC United of Manchester are authorised only to deal with that individual and are not obliged to have regard to any requests from the other entrants.
- 3. Entrants shall agree to purchase chances in monthly prize draws for a minimum period of 12 months.
- 4. No more than 250 entries will be accepted in total. The promoter reserves the right to delay or cancel the prize draw should the number of entrants reach less than 200.
